

UoNA Student Code of Conduct

Students are expected to behave and treat others on campus as professional scholars. Students attend the University from all parts of the world and from many varied backgrounds. This diversity provides a rich environment for the free exploration and expression of ideas, and students are expected to participate fully and to uphold the right of others to do the same.

Students are expected to abide by all public laws and generally accepted professional standards, to comply with all regulations and policies of the University, and to conduct themselves professionally when interacting with fellow students, faculty, and staff. The University reserves the right to place a student on disciplinary warning, probation, suspension, or dismissal, who engages in unsatisfactory conduct such as dishonesty; failure to adhere to rules and regulations; destruction or theft of property; participation in activity that impinges on the rights of others; or possession or consumption of alcoholic beverages or illegal drugs at any time on these premises.

Academic Integrity.

Includes plagiarism & all elements as defined in the policy. Faculty are required to submit a record of all violations and penalties to the VP of Academic Affairs.

Collegial Responsibility.

Includes (a) Timely submission of assignments and (b) Participation in scheduled class sessions or activities

Appeals Process.

Students may submit a request for reconsideration of a grade if they have extenuating circumstances and file the request within two weeks of the occurrence. The request must be filed by a college representative, one of the instructor or the university's representative, while still maintaining communication with the instructor. In cases where the issue has not been satisfactorily resolved by the college representative, the student may appeal to the VP of Academic Affairs. The student must submit a written appeal to the VP of Academic Affairs within two weeks of the occurrence. The appeal must include a statement of the student's position, a statement of the instructor's position, and a statement of the college representative's position. The VP of Academic Affairs will review the appeal and make a final decision. The student will be notified of the decision within two weeks of the appeal. If the student is dissatisfied with the decision, they may appeal to the University's Board of Trustees. The student must submit a written appeal to the Board of Trustees within two weeks of the decision. The appeal must include a statement of the student's position, a statement of the instructor's position, a statement of the college representative's position, and a statement of the VP of Academic Affairs' position. The Board of Trustees will review the appeal and make a final decision. The student will be notified of the decision within two weeks of the appeal.
